The field of habilitation proceedings and inaugural proceedings include knowledge of various aspects of the development of human society with an emphasis on ethnicity and ethnic processes. It considers the extent to which scientific procedures can reliably identify, define, classify, construct, reconstruct, redefine and apply in the scientific sphere, the professional community and social practice based on relevant sources and resources.

The core topics of the habilitation and inauguration proceedings include knowledge, skills and competencies in ethnology, culturology, cultural and social anthropology, history, general and Slovak history, archiving, auxiliary historical sciences, archeology, museology and religion, their methodology and practice. Secondary also in linguistics, sociology, psychology, philosophy, Slavic studies, pedagogy, economics, historical and human geography, ecology and political science.

The condition of the relevance of the interdisciplinary approach within the habilitation and inauguration proceedings is the scientific and pedagogical contribution in the field of ethnology, primarily issues of ethnicity and ethnic processes, secondarily a significant contribution to the development of ethnography, folklore, cultural heritage and national culture.
